

Standard of Conduct Agreement

The Standard of Conduct Agreement was developed to ensure that staff, parents, students, and our church will have an environment conducive to learning and spiritual growth at Green Valley Christian Prep/ High School. We are committed to teach the students to love and to respect one another.

Discipline is the process of teaching a student how to change wrong behavior into right behavior. Our goal is to teach students self-control that will lead to right choices. It is very important to set a standard for the school so that the students know what is expected of them. We feel very strongly that by teaching morals and Christian values the student will develop life skills that will shape them into honorable adults.

Every student in Preparatory or High School, must sign and adhere to the Standard of Conduct Agreement. The parents will also be asked to sign this agreement so the school and home will be in unity.

Standard Conduct

To maintain consistent Christian character of courtesy, kindness, morality, honesty, and submission to authority. (Church attendance will strengthen Christian character and is mandatory)

To refrain from action that might offend or appear to be ungodly. For example: swearing or abusive language, defiance of authority, lying, smoking, alcoholic beverages, drugs, fighting, and anything else that the Bible stands against.

Students of Green Valley Christian Junior/High Preparatory School are expected to abide by these Biblical standards throughout their enrollment whether at home, school, or elsewhere.

Students that are found to be out of harmony with these standards may be asked to withdraw from GVCPHS.

Behavior at School: Your best behavior should be displayed at school or at any school-sponsored activity. Please be advised that any student who is guilty of the following may be asked to withdraw from GVCPHS:

Willful disobedience

Open defiance of authority

The use of profanity or obscene language

Stealing or cheating

Abuse of property (**Parents will be responsible for the cost of abused property**)

Physically hitting or hurting another student, teacher or GVCPHS employee

There is zero tolerance for any weapons on school grounds

There is zero tolerance for any drugs, tobacco or alcohol on school grounds

It is expected that parents and students will accept responsibility for their actions.

Whenever students or parents are at a school sponsored event you are all representative of GVCPHS and Christian character must be displayed at all times.

Statement of Cooperation

I pledge not to interfere with the school in its efforts to administer discipline to my child in accordance with the standards the school sets.

If my child is voluntarily withdrawn or is requested to withdraw by the school, it is understood and accepted that no refund of registration fee, book fee, activity fee, nor tuition will be made.

Also, please be notified that Green Valley Christian School is exempt from the provisions of the Private Elementary and Secondary Education Authorization Act.
